Squid Amendment (Committee of the Whole)

Move to recommend to the Council to leave the current MSB goals and objectives in place during the development of the Squid Capacity Amendment.

King for Committee (21/0/0)

Motion carries

Move that the Maine longfin issue be moved to considered but rejected.

Motion carries

Move to move forward with additional analysis on the following re-qualification alternatives for longfin squid (all of 2013 would count for landings):

- a. No action
- b. 1997-2015, 10,000-pound best year threshold
- c. 2003-2013, 25,000-pounds best year threshold
- d. 1997-2013 10,000-pound best year threshold
- e. 1997-2013 with 50,000-pound average threshold

Move to amend c to remove “all poundage threshold” and insert “25,000 pounds best year threshold”
