

### 1st Quarter Enforcement and Compliance

#### Summary

So far in the first quarter, there were 63 documented patrols, allowing critical face-to-face interaction between our field staff and the industry; 28 documented instances of outreach (not an exhaustive list; includes phone calls with industry, dock visits, trade shows, presentations, etc.); and 15 meetings. This list does not include the extensive outreach that the VMS team provides on a daily basis, nor can it fully capture the interaction our agents, officers, and support staff regularly have with industry.




Figure 2: Incidents opened from October 1, 2015 through November 25, 2015. 137 incidents were opened.

### Complaints by Type 1<sup>st</sup> Quarter Fiscal Year 2016




Figure 3: Complaints opened from October 1, 2015 through November 25, 2015. 4 complaints were opened.





Figure 4: Inspections performed from October 1, 2015 through November 25, 2015. 23inspections were performed. 21 inspections observed compliance and 2 inspections observed non-compliance.

#### INCIDENTS DISPOSITIONS 1st Quarter 2015 & 2016




Figure 6. Status of incidents in the 1st quarter of FY2015 (181 completed, 53 ongoing) and 1st quarter FY2016 (79 completed, 60 ongoing).

## 1<sup>st</sup> Quarter, Fiscal Year 2016 Highlights

Logan Gregory has been selected to be OLE's next Deputy Director. From Student Intern to Assistant Director, Logan has dedicated himself to accomplishing OLE's mission to protect marine wildlife, sanctuaries and monuments, and critical habitat by enforcing domestic laws and international treaty obligations designed to ensure these natural resources are available for future generations. Logan's long list of accomplishments with OLE over the last 22 years is nothing short of remarkable – from his earliest days as an Enforcement Officer in the Southeast, through assignments with increasing levels of responsibility as a Special Agent, Assistant Special Agent in Charge, and Assistant Director in the Northeast, Logan has truly covered the waterfront. Logan will officially assume his new duties as Deputy Director on December 13, 2015.

#### Magnuson-Stevens Fishery Conservation and Management Act

A \$750 Summary Settlement was issued to a charter boat captain who sold yellowfin tuna to a non-federally permitted dealer.

A \$500 Summary Settlement was issued to a recreational angler who retained an undersized white marlin.

A \$1,000 Summary Settlement was issued to a charter boat captain who on two separate occasions failed to report the landing of a swordfish and white marlin.

Two separate summary settlements, each worth \$1000, were issued to the owner and operator(s) of a New York charter boat fishing vessel that fished on several trips without federal permits.

A \$500 Summary Settlement was issued to a charter boat operator who was in possession of black seabass without proper northeast permits. The operator was also issued a written warning for failing to obtain an operator permit.

A \$500 summary settlement was issued to a recreational vessel owner for possession of two Cod in the Gulf of Maine.

A \$250 summary settlement was issued to the owner/operator of a lobster boat in Marshfield, MA for failing to maintain a VTR logbook.

### **Cooperative Enforcement**

OLE officers conducted joint patrols with JEA partners in Delaware and Maryland as part of a black sea bass saturation during the closed black sea bass season in the EEZ. An emphasis was placed on detecting black seabass being retained during the closed season and illegal black sea bass commercial traps in closed gear artificial reefs. Numerous charter and recreational vessels were contacted that resulted in 1 written warning being issued and 2 Summary Settlements pending for possession of black sea bass in closed season and possession of undersized/mutilated summer flounder.

### Northeast VMS Program

The Fixed Gear Sector Manager sent a letter to the GARFO Regional Administrator requesting consideration to use 'Harbor Mode' or a Power Down exemption for member vessels that recently transitioned from the old SkyMate to a McMurdo VMS. These vessels are on moorings and the high power consumption is draining their batteries. OLE has agreed that 'Harbor Mode' (as described by McMurdo) may be used by vessel owners with McMurdo-equipped vessels in port as long as the owners continue to meet the reporting requirements of the regulations at 50 CFR 648.10. Harbor Mode is not authorized for use when the vessel is away from the dock/mooring.

### **Observer Program Highlights**
