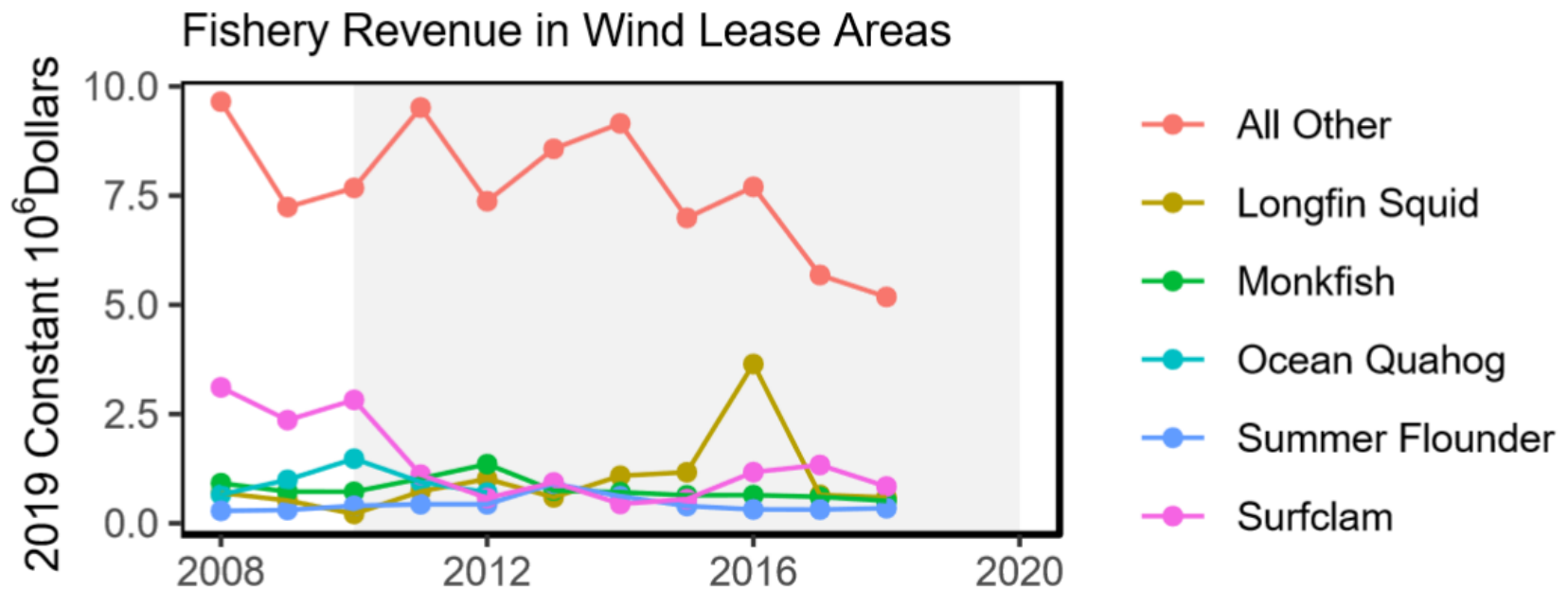


Figure 48: Wind energy revenue in the Mid-Atlantic
