## 3<sup>rd</sup> Quarter Enforcement and Compliance

#### Summary

So far in the third quarter, there were 142 documented patrols, allowing critical face-to-face interaction between our field staff and the industry; 54 documented instances of outreach (not an exhaustive list; includes phone calls with industry, dock visits, trade shows, presentations, etc.); and 9 meetings. This list does not include the extensive outreach that the VMS team provides on a daily basis, nor can it fully capture the interaction our agents, officers, and support staff regularly have with industry.

# ACIs Reported 3rd Quarter Fiscal Year 2016




Figure 1: 230 ACIs reported from April 1, 2016 through June 10, 2016. The chart is broken down by patrols, outreach, other (collateral duties, homeland security, and info gathering) and meetings.




Figure 2: Incidents opened from April 1, 2016 through June 10, 2016. 334 incidents were opened.




Figure 3: Complaints opened from April 1, 2016 through June 10, 2016. 19 complaints were opened.




Figure 4. FY2016 3<sup>rd</sup> quarter: 12 inspections, 292 investigations, 19 complaints, 11 other. **334 total** FY2015 3<sup>rd</sup> quarter: 58 inspections, 105 investigations , 12 complaints, 4 other. **179 total**




Figure 5. Status of incidents in the 3<sup>rd</sup> quarter of FY2015 (112 completed, 67 ongoing) and 3<sup>rd</sup> quarter FY2016 (275 completed, 59 ongoing).

## 3<sup>rd</sup> Quarter, Fiscal Year 2016 Highlights

#### Magnuson-Stevens Fishery Conservation and Management Act

A federal indictment in the Carlos Rafael investigation was unsealed. The indictment consists of a one count conspiracy to falsify NOAA dealer reports, twenty-five counts of submitting falsified records and one count of bulk cash smuggling. Carlos Rafael, the owner of one of the largest commercial fishing businesses in the United States and a Bristol County Sheriff's Deputy were charged in connection with a long-running scheme involving submitting falsified records to NOAA to evade federal fishing quotas and then smuggling a portion of the profits to Portugal.

On June 2 nd , James Kaminsky, a fisherman from Mattituck, New York, pleaded guilty in the Eastern District of New York/Islip, to federal felonies stemming from his role in systematically covering up the landing and sale of illegal fluke (summer flounder), scup and black sea bass that were overharvested in violation of New York state quotas and the federal Research Set-Aside Program. Kaminsky pleaded guilty to one count of aiding and abetting false documents in connection with a scheme that ran from May through August 2011.
