Council Undertakes Independent Review to Assess Past Performance and Solicit Suggestions for Improvement

The New England Fishery Management Council is launching an independent "program review" and is asking stakeholders who interact with the Council to participate in the undertaking.

"Like every organization, the Council can benefit from periodically reviewing how it does business," said Council Chairman Dr. John Quinn, Director of Public Interest Law Programs at the University of Massachusetts School of Law. "That's why we initiated an external review of our operations. We want to know three things: what we're doing right; what we're doing wrong; and how we can improve the way we serve the people who are involved in our fisheries and the public overall."

Stakeholder input is being solicited through two primary avenues: (1) a short online survey; and (2) 14 port meetings from Maine to New Jersey, coupled with a webinar option for anyone who can't attend an inperson meeting or who wants to contribute additional comments. 

WHO'S IN CHARGE OF THE EXTERNAL REVIEW

The Council Program Review will be conducted by an external panel of managers and scientists from other regions and/or international fisheries entities who have a strong understanding of U.S. federal fisheries management but no recent involvement or affiliation with the New England Council. The review panel will meet for one week in early 2018 to discuss Council operations and carry out the Terms of Reference for the review. The meeting will be open to the public.

The Council has enlisted the help of two contractors to support this review process as follows:

 Council Undertakes Independent Review to Assess Past Performance and Solicit Suggestions for Improvement

The New England Fishery Management Council is undergoing an independent review to: (1) assess past performance; (2) gather feedback on strengths and weaknesses of the Council process and operations; and (3) identify potential areas for improvements.

Stakeholder input is critical to this review. The Council is encouraging commercial and recreational fishermen, industry leaders, fishery managers, members of non-governmental organizations, and other stakeholders to participate in the effort.

REVIEW PANEL: The review will be conducted by an independent sixmember panel of fishery managers and scientists from other regions. Each member has a strong understanding of U.S. federal fisheries management but no recent affiliation with the New England Council. Some also have international experience.

EXTERNAL REVIEW MEETING DATES AND LOCATION: The review panel will meet Tuesday, March 13 through Friday, March 16 to discuss Council operations and conduct its work. The meeting, which is open to the public, will be held at the <u>Hilton Garden Inn</u>, <u>Boston Logan Airport</u>.

PANEL MEMBERS: Three fishery managers and three scientists have been selected to serve on the panel. They are:

- Robert Beal, Executive Director, Atlantic States Marine Fisheries
 Commission Mr. Beal brings a unique, Maine-to-Florida state-waters
 perspective to the table. He also is familiar with the operations of three
 different fishery management councils that are responsible for federal waters
 management of many of the same species ASMFC oversees in state waters.
- Robert Gill, former member and Chair, Gulf of Mexico Fishery
 Management Council; current member, Gulf Council's Scientific and
 Statistical Committee In addition to his Gulf Council involvement, Mr. Gill
 has extensive business and marketing experience. Since 1986, he has coowned and operated Shrimp Landing, a dockside wholesale/retail seafood
 business that ships fresh and frozen seafood throughout the U.S. and
 Canada.

- Dan Hull, Chairman, North Pacific Fishery Management Council In addition to his fishery management responsibilities, Mr. Hull is an experienced Alaska longline halibut and sablefish fisherman. He owns the commercial fishing vessel *Gretchen S* through Hull Fisheries LLC.
- Dr. Pamela Mace, Principal Adviser Fisheries Science, Ministry for Primary Industries, New Zealand Dr. Mace was Chief Scientist for the former New Zealand Ministry of Fisheries, which merged with the Ministry of Agriculture and Forestry, resulting in her current title. She has extensive scientific experience involving Canadian, U.S., and New Zealand fisheries. Her work most recently has focused on precautionary approaches and harvest control rules, primarily for fishery management uses in the U.S. and New Zealand, and developing and implementing national standards for overfishing definitions and rebuilding plans in both countries, among other initiatives.
- Dr. Bonnie McCay, Board of Governors Distinguished Service Professor, Rutgers University— Dr. McCay, an anthropologist, works in the Department of Human Ecology within the School of Environmental and Biological Sciences at Rutgers. Her research and teaching have focused on challenges and policies for managing common pool resources such as fish and shellfish, with particular attention to intersections of ecology, community, and social institutions of science, law, and property.
- Dr. Kenny Rose, France-Merrick Professor in Sustainable Ecosystem Restoration, Horn Point Laboratory, University of Maryland Center for Environmental Science – Dr. Rose's research centers on using mathematical and computer simulation modeling to predict and better understand fish population and food web dynamics in estuaries, lakes, reservoirs, and oceans. He recently was presented with the American Fisheries Society's Award of Excellence, which recognizes lifetime achievement.

- Tidal Bay Consulting <u>Tidal Bay</u> will compile background documents for the review panel, provide support for the review meeting itself, and prepare the panel's final report.

Stakeholder input *will be confidential*. Specific statements, ideas, and perspectives will not be attributed to individuals. The Fisheries Forum will summarize input based on themes, fishery, and/or geography as appropriate and prepare a report for the review panel. Once completed, this report will be available to the public and posted on this webpage.
